- Scammers have accessed the SBCWRT website and are using contact information (email addresses, phone numbers) to send out fake requests for money
- When receiving email correspondence from any SBCWRT member, do the following that requests a favor or money, do all of the following:
  - Upon receipt of an email, DO NOT immediately reply to it (Continued on back side)

- Check email address to see if it matches an address you have seen before from an RT member
- If the email address does not match the address you have been using for an RT member, delete the email; attempt to contact the RT member using either a phone number of their real email address to advise them of the scam

### This Day in the Civil War: January 28 (By Abby Eller)

**1861**: The arsenal at Augusta, GA falls into state hands. Union troops depart Ft Monroe, VA to reinforce Ft Pickens in Florida.

<u>1862</u>: Pres Lincoln issues Genl War Order #1: "that Feb 22, 1862 be the day for a general movement of the land and naval forces of the United States against the insurgent forces." Flag Officer Foote notifies Genl Henry Halleck that Foote and Genl Grant agree Ft Henry might be taken with four gunboats and the troops available

<u>1863</u>: Cmdr John L Worden of ironclad USS Monitor, takes command of ironclad, USS Montauk. Accompanied by 4 wooden ships, Montauk attacks shore batteries at Ft McAllister, GA on Ogeechee River. Fleet is unable to inflict significant damage due to obstructions which the Confederates have placed in the river. Worden and the fleet are forced to withdraw.

<u>1864</u>: US steamer Western Metropolis captures British blockade runner Rosita off coast of Key West, FL. Rosita is loaded with a cargo of liquor and cigars, Braxton Bragg summoned to Richmond to confer with Pres Davis.

<u>1865</u>: To represent the Confederacy in upcoming peace talks with Pres Lincoln, Pres Davis appoints Alexander Stephens, Robert MT Hunter, and John A Campbell. In SC, skirmishing along Combahee River, SC between Sherman's troops and Confederate defenders, as Sherman's forces head towards Columbia. Grant summons troops commanded by Genl Schofield to launch the assault on Wilmington, NC.

### <u>Person of the Month: Hannibal Hamlin (By Abby Eller)</u> Background

- Hannibal Hamlin was born in 1809, was an attorney-politician and a native of Maine who had public service career that spanned 50 years.
- Admitted to the bar in 1833, practiced law in Maine. Initially a Democrat, was elected to the state House of Representatives in 1835, then appointed by governor of Maine to state military staff
- Aroostook War 1838-1839:
  - Was an armed confrontation between the US and Britain over northern boundary of Maine and southern boundary of New Brunswick in Canada.
  - There were no casualties except for two Canadian militiamen who were attacked by black bears
  - The Webster-Ashburton treaty signed in 1842 established present boundary; Hamlin helped negotiate an end to the War which was last armed confrontation between the US and Britain.
- In the 1840's, Hamlin represented Maine in the US House of Representatives, then in the US Senate
- Was antislavery supporting Wilmot Proviso and opposing the Compromise of 1850 and the Kansas-Nebraska Act

#### • Civil War

- In 1856, Hamlin joined Republican Party. In the election campaign of 1860, was chosen not only to geographically balance the Republican ticket, but to also persuade antislavery Democrats to vote Republican.
- Hamlin was not personally close to Lincoln. However, as presiding officer of the US Senate, supported Lincoln's legislative programs.

#### **Post-Civil War**

- Was appointed by President Johnson to be Collector of the Port of Boston
- Hamlin resigned in protest over Johnson's harsh Reconstruction policies meant to punish the South
- In 1869 Hamlin was again elected to US Senate served two more terms
- His last office was as Ambassador to Spain before he retired to live in Bangor Maine, where he died in 1891.
